### DEMOLITION DEBRIS DISPOSAL FEE

A demolition debris hauling fee shall be paid at the time a demolition or roofing permit application is made and the owner or contractor intends to haul its own debris. The roofing and demolition debris hauling fee will be one dollar and fifty cents (\$1.50) per cubic yard. The number of cubic yards calculated using the formulas in this section shall be multiplied by \$1.50 to establish the debris hauling fee for each permit. *Ordinance No. 3944-06; Sec. 74-128*

Demolition Debris – The cubic yards of debris hauled from a demolition project shall be determined by multiplying the length times the width times the height in feet of the structure to be demolished, times a conversion constant which provides the volume of debris contained in the structure, in cubic yards. The conversion constant for a wood or metal frame structure is 0.009. The conversion constant for a CBS or masonry structure is 0.011.
