A request by Harvey E. Oyer, III, of Shutts and Bowen, LLP, on behalf of CityPlace Retail, LLC, for the approval of a Major Planned Development Amendment to the CityPlace Commercial Planned Development (CPD) to amend the text within the Rosemary Square Core Development Regulations to amend the Rosemary Square Plaza subarea relating to permitting artificial turf; to amend the language relating to Small Business Enterprise firm participation; to reduce the amount of parking required for new office and retail uses; and to clarify the requirements for the demolition of existing structures within the area covered by the Rosemary Square Core Regulating Plan.
