RESOLUTION NO. 244-23

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF WEST PALM BEACH, FLORIDA, DECLARING THAT CERTAIN CITY AND COMMUNITY REDEVELOPMENT AGENCY OWNED PROPERTIES ARE SUITABLE FOR AFFORDABLE HOUSING AS REQUIRED BY FLORIDA STATUTE 166.0451; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, as required by Florida Statute 166.04151, the City of West Palm Beach must prepare an inventory list of all real property which the City or any dependent special district within its boundaries hold fee simple title and which are appropriate for use of affordable housing; and

WHEREAS, dependent special districts within West Palm Beach include the West Palm Beach Community Redevelopment Agency (CRA); and

WHEREAS, the statute further requires that the City make the inventory list publicly available on its website to encourage the development of affordable housing; and

WHEREAS, the City and CRA staff reviewed the list of City- and CRA-owned properties to determine the best use of the parcels, taking into consideration whether they are needed for public purposes and/or economic development, site characteristics, environmental and other relevant factors; and

WHEREAS, City and CRA staff also assessed the history of each property to determine whether the parcels are subject to deed restrictions or other circumstances or conditions which may prohibit, restrict, or otherwise affect the disposition of the properties; and

WHEREAS, the City Commission hereby desires to identify those properties determined to be suitable for affordable housing purposes;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF WEST PALM BEACH, FLORIDA, that:

- **SECTION 1:** The City Commission hereby finds and determines that the parcels of land, as described in **Exhibit A** ("the Property Inventory List"), are suitable for affordable housing purposes, as required by Florida Statute 166.04151:
- **SECTION 2:** The City Commission directs that the Property Inventory List be posted on the City's website as soon as feasible, to encourage the development of affordable housing.
- **<u>SECTION 3</u>**: This Resolution shall take effect immediately upon adoption.
